

# Comprehensive Immigration Reform

Understanding the changes needed in US immigration policy

*Do not be conformed to this world but be transformed  
by the renewing of your minds, so that  
you may discern what is the will of God – what is good and acceptable and perfect. **Romans 12:2***

## Information:

Current US immigration policy is complicated and governmental departments face a backlog of applications upwards of 5 to 7 years. If a foreign born person wishes to come to the US to work and live there are only a few ways he/she can obtain the necessary visa: obtain refugee/asylum status; win one of only 50,000 visas available each year in the US sponsored "lottery" (in 2009 9.1 million qualified applications were received for the lottery); or have a sponsor that is either employment or family based. While this sounds reasonable the parameters around these options are quite restricted. Since the visas for refugees and asylum seekers are specialized, the focus here will be on family and employment based sponsorships.

Coming to the US under a sponsorship program is lengthy and complex. A worker may be sponsored by an employer if he/she has a specialized field of expertise and a job offer. An immediate family member (such as spouse, adult child, or parent) who is a US citizen or Lawful Permanent Resident can act as a sponsor. Faced with these severe limitations and waiting periods of five years or more, many may see no other choice but to immigrate to the US without proper documentation.

It is estimated that approximately 12 million undocumented people reside in the US and another estimated 300,000 come each year. Billions of dollars have been poured into enforcement measures such as increasing border patrol presence, construction of border fences, and mass deportation of undocumented workers. However, statistics show that this is not stopping the migration of workers into the US. For the last three years

there have been efforts to overhaul immigration policy through enacting Comprehensive Immigration Reform yet congress has refused to act even though those on all sides of the immigration issue agree the current system is broken.

## Insight:

The Presbyterian Church (USA) has called for Comprehensive Immigration Reform (visit [www.pcusa.org](http://www.pcusa.org) to access information including a Bible study) through action of the 216<sup>th</sup> General Assembly and by signing on to faith initiatives which urge congress to act. These statements by the church support effective immigration reforms that will adhere to the following standards:

- Create a process for undocumented immigrants in the US to earn their legal status
- Reduce waiting periods and uphold family unity
- Protect workers from exploitation



Visas have remained static over the years even though demand has increased. The market for low-skill workers has increased yet the number of visas released each year is very low. Only 66,000 visas per year are available to low-skilled, nonagricultural workers and 30,000 for agricultural workers yet hundreds of thousands of these jobs are filled each year by immigrant labor, including undocumented immigrants.<sup>1</sup> These arbitrary caps on low-skilled workers help create an environment that fosters the undocumented migration of workers and fear of deportation among workers which results in silence on abuses and dangerous work environments.

#### **Invitation to Act:**

A large grassroots effort is needed to ensure congress acts this year on immigration.
